Ordinance 372 Annexation 210 E. South, RV Park; Ordinance 373 Annexation Archer City Lake; Ordinance 374 Annexation Archer City Golf Course

Council was presented the ordinances to annex the following areas into the city limits: (1) an area of approximately 1.08-acres out of the 36.392-acre tract of land, Abstract 727, Certificate 14, Hooper & Wade Survey, located at 210 East South Street; and (2) an area of approximately 75.6-acres out of the 148.03-acre tract of land, Block No. 151, G.W. Barnett Survey, Abstract 19, and containing Archer City Lake; and (3) an area of approximately 44.8-acres in the J.W. Armstrong Survey, Abstract 762 and 0.369-acres in the Burkett Addition, commonly known as the Archer City Golf Course; all located in Archer County, Texas, and also located in the City's extraterritorial jurisdiction. OLD BUSINESS

Resolution 466 4B Archer County Rodeo Association Project

Kim Whitsitt presented a resolution authorizing a project to contribute up to \$3,500.00 of 4B funds to the Archer County Rodeo Association to fund a concrete entry project. Billy Burks made a motion approving the resolution. Debra Haehn seconded the motion. All members present voted "Aye".

NEW BUSINESS CONTINUED

Ambulance Service Bids

Mayor Truette addressed Council concerning the ambulance service for the upcoming fiscal year and recommended advertising for bids for 2023 – 2024. The current contract with AMR expires October 31, 2023. After further discussion about the bidding process including accepting alternate bids for service, Leslie Hash made the motion to proceed with advertising for bids for ambulance service for the term of November 1, 2023 – October 31, 2024. Megan Randall seconded the motion. All members present voted "Aye".

Emergency Services District

Mayor Truette addressed Council concerning the ESD and recommended focusing on the ambulance service budget until the budget process is over in September and resuming discussion of the ESD at that time. The consensus of Council is to focus on the budget and resume discussion of the ESD in October.

Adjournment

There being no further business to come before the City Council, Billy Burks moved to adjourn at 7:35 p.m. Debra Haehn seconded the motion. All members present voted "Aye".
